RCC/RPL Process

To progress from a PRINCE2/MSP certification to further qualification all you need to do is to successfully complete the PRINCE2 or MSP course:

- Return to work
- Practice some of the skills and apply some of the knowledge that you have learnt with PRINCE2 and/or MSP
- Gather examples of project management work that you have done or are doing
- Complete an online assessment record book
- Attend an assessment interview (where we will sit with you and discuss your previous and current project work)
 - You may need to provide other pieces of evidence for your project work (as discussed and agreed with your assessor)
- Reap the benefits of achieving a nationally recognised project management qualification
